Ash Wednesday and Good Friday are days of fasting and abstinence. All Fridays in Lent are days of abstinence. Fasting means eating only one full meal with two smaller meals, which together do not equal the full meal. No snacking or eating between meals is allowed. Fasting obliges all Catholics between the ages of 18 and 59. Abstinence means eating no meat, and no soup or gravy made from meat. Abstinence obliges all Catholics over the age of 14. Sickness, hard manual labor, pregnancy, etc. automatically excuse a person from these obligations. Nevertheless, it should be pointed out that these are serious obligations. In cases of doubt or question, the priest who hears a person's confession should be consulted.

God has carefully, tenderly created every person in His own image and likeness, to be in a loving relationship with Himself. From each tiny child knit within a mother's womb, to every person approaching death, all are loved perfectly and completely by God: "It is therefore a service of love which we are all committed to ensure to our neighbor, that his or her life may be always defended and promoted, especially when it is weak or threatened. In a world in which those who are most vulnerable are so often overlooked and disregarded, Christ calls us to embrace and uphold the unconditional dignity of every human life. In answering this call, we help to build a new culture of life, the fruit of the culture of truth and of love.

Please pray and fast that proabortionists' efforts to legalize abortion until birth in the State of Nebraska will fail. No human person has a moral right to do what is morally wrong. God has revealed that for every human person it is intrinsically evil to take innocent human life. Please take the time to read the following to be educated on this important issue. On November 16, 2023, the pro-abortion coalition, formed under the misguided name of "Protect Our Rights Nebraska," formally launched its petition drive with a press conference and launch party. This group will need to collect valid signatures from 10% of the registered voters in the state, or just under 123,000 signatures. The signatures also must be collected from 5% of the registered voters in 38 different Nebraska counties to put this decision on the November 5, 2024 ballot for Nebraska voters. They have until approximately July 2024 to collect these signatures. What the voters need to understand is that ballot measures change a state constitution, take precedence over laws passed by state legislators, and can only be overturned by another ballot measure. On November 15, 2023, Protect Our Rights abortion advocates released their ballot initiative language, which would enshrine a right to abortion until birth in our Nebraska Constitution. The petition language is as follows: "All persons shall have a fundamental right to abortion until fetal viability, or when needed to protect the life or health of the pregnant patient, without interference from the state or its political subdivisions. Fetal viability means the point in pregnancy when, in the professional judgment of the patient's treating health care practitioner, there is a significant likelihood of the fetus' sustained survival outside the uterus without the application of

extraordinary medical measures." The amendment would allow for: • Abortion throughout the entire pregnancy The amendment leaves post-viability abortion for "health" of the mother to the discretion of the abortionist. Without defining "health," courts have found that it can be based on non-medical factors, including mental, spiritual, financial or familial health. Furthermore, viability is defined as being based solely on the abortionist's judgment and would not include any baby who needs "extraordinary medical measures," which could be as simple as a short stay in the NICU. •The elimination of health and safety protections for women Language on the fundamental right to abortion "without interference from the state" puts all of Nebraska's medical safeguards at risk. This includes obtaining informed consent and performing a medical screening, seeing a physician in person or even seeing a medical professional at all. It would allow pills to be sold through the mail by people with no medical background. •The evisceration of parental rights By using the words "all persons" in the amendment, this will mean parents will not have any ability to consent or even know if their minor daughter seeks an abortion. They may also have no recourse if their daughter is harmed during the abortion. And in fact, parents WILL have financial liability for any follow-up physical and/or mental care their minor daughter may require postabortion. This is an orchestrated attempt to mislead Nebraskans into thinking this is a "reasonable" measure, but the reality is that this initiative is abortion-ondemand, up until the birth of a baby. This should be rejected by the Nebraska voter. Nebraska's current law allows for abortion throughout the first 12 weeks of pregnancy with exceptions for rape, incest, life of the mother and medical emergencies. Nebraska statistical data indicates 90% of abortions are performed before 12 weeks gestation. This ballot measure is entirely proabortion and it does not reflect the values of Nebraskans. For those wishing to incorporate a weekly Mass,

Stations of the Cross, or Adoration into their Lenten plans, the tentative schedule for Wednesdays of Lent (February 21-all of March) will be Stations at 5:30pm, Mass at 6:00pm, followed by Adoration until 9:00pm. In addition, one could use these means also to gain a plenary indulgence by adoring the Lord in the Blessed Sacrament during Adoration for at least a half-hour, praying with the Parish the Stations of the Cross, or reading sacred scripture with devotion for at least a halfhour. However, we must remember there are some stipulations provided which must be met in order for the indulgences to be plenary. If all the conditions are not met, we receive partial indulgences, but not plenary indulgences. Conditions to be met: 1.) Sacramentally confess your sins in Confession within 20 days before or after the indulgent act. (one sacramental Confession is sufficient for several indulgences) 2.) Be in a state of grace (which you receive from Confession) and have a complete detachment from sin. This does not mean that you are to be sinless, but you are to have a detachment from sin. 3.) Pray for the intentions of the Holy Father. You can do this by simply reciting the Our Father and one Hail Mary for the intentions of the Holy Father. 4.) Reception of Holy Communion (must receive Holy Communion for each plenary indulgence sought) It is permissible that Holy Communion may be received several days before or after obtaining the indulgence, but it is preferable it is received the same day of the indulgent act. 5.) One must have a general intention of gaining an indulgence beforehand.
